Norma welcomed all to the third meeting of COGITS and apologies were noted. Attendees gave a brief introduction of themselves and their organisations.

Helen Forsyth gave an account of a situation that had arisen that seriously affected the Housing Partnership she was running in Edinburgh. This formed the basis of a session led by Helen to take attendees thoughts on 3 questions:

- What has become more difficult in leading your team through this crisis?
- What strategies have you considered to support your team in the response to the crisis?
- What ideas have you had to look after your own well-being?

Attendees contributed a range of responses. Notes of the contributions are attached in a separate document.

# **Matters Arising**

Purposes of COGITS -The three aims of the group were read out as a reminder to the group.

- 1. To lead the third sector's influence on the public and private sectors to achieve collective goals
- 2. To provide a safe, democratic and supportive network for third sector decision makers in Dumfries and Galloway
- 3. To create an environment for strategic collaborations which strengthen the third sector's ability to participate in partnerships

Alan Hall (TSDG Communications Manager) has update SLACK **ACTION**: Alan Hall to send out SLACK link again with minutes

No progress on TSDG representation

**ACTION:** Keep on agenda

The "Big Report" has now been shared elected representatives and all other Partnerships including the REP (Regional Economic Partnership) Contains long-standing recommendations for change.

## **Regional Economic Partnership**

Norma sits on the REP as Third Sector representative. Administration of the REP is by South of Scotland Enterprise (SOSE), chaired by an elected representative. Norma noted the Third Sector is under-represented on the REP. Norma's notes of meetings are published on <u>TSDG</u> <u>website</u>. REP is pushing ahead with Regional Economic Strategy. Consultants not yet (as far as is known) appointed. Norma noted there's not much time for a full consultation of the ten year plan given the deadline for the first draft by March publication. Norma suggested keeping an eye on this.

**ACTION:** Spring session on REP for COGITS.

Q from floor: How could members support TSDG on the REP?

A Norma – Bring concerns to me, councillors, Economic leadership Group. Norma proposed COGITS should think how to influence the REP

## **Scottish Shared Prosperity Fund**

NAH introduced two documents: Letter from Ivan McKee, MSP, Minister for Trade, Investment and Innovation, and Scotland's proposals for a Scottish Shared Prosperity Fund There was a discussion about the timescales and the administration of the new fund.

- Q: Does it matter who administers the fund if we get our fair share?
- Q: Would the funding go to SOSE?
- Q: Would there be any shortfalls if funds allocated through UK Departments?
- Q: Who decides who gets the money and using what criteria?
- Q Is the position letter linked to the SG Independence agenda?
- C: Too much emphasis on job creation regardless of social worth
- C: Green agenda has been overlooked

Norms advised this subject is on the REP meeting tomorrow (11/12/2020) and that she would feedback this discussion at that meeting.
